IMPORTANT - LIABILITY WAIVER AGREEMENT

MOGOLLON MONSTER MUDDA LIABILITY WAIVER:

____ I understand that entering The Mogollon Monster Mudda is a hazardous activity.

____ I understand that The Mogollon Monster Mudda presents extreme obstacles including, but not limited to, fire, mud pits and steep hills.

---____ I agree not to participate unless I am medically able.

____ I agree to not consume alcohol prior to The Mogollon Monster Mudda or ingest any medicines or substances that will inhibit my mental or physical ability to safely and effectively participate in The Mogollon Monster Mudda.

____ I agree to abide by any decision of a race official relative to my ability to safely complete the race.

____ I agree to obey all civil and criminal laws at all times.

____ I assume all risks associated with competing in The Mogollon Monster Mudda, including but not limited to falls, contact with other participants, negligent or wanton acts of other participants, completing all obstacles, defects or condition of premises, the effects of the weather, including high heat and/or humidity, all such risks being known and appreciated by me.

____ I agree that Town of Payson is not responsible for any personal items or property that are lost or stolen.

____ I consent to emergency medical care and transportation in order to obtain treatment in the event of injury to me as medical professionals may deem appropriate. This Release extends to any liability arising out of or in any way connected with the medical treatment and transportation provided in the event of an emergency.

____ I understand and will abide by the rule that no wheeled baby conveyances or other wheeled means of conveyance, or pets are permitted in the race.

____ I grant permission to the Town of Payson, its affiliates, sponsors, and assigns to use any photographs, motion pictures, recordings or any other record of this event for any purpose including but not limited to promoting, advertising and marketing purposes. Any and all photographs, motion pictures, recordings or other records of the event are the sole property of the Town of Payson.

____ I understand that all entries are final with no refunds.

____ The official race directors reserve the right in any event of emergency or local or national disaster to cancel the race and in the event of cancellation or change there is no refund of entry fees.

____ Participants are expected to exhibit appropriate behavior at all times, including obeying all laws. This includes respect for all people, equipment, and facilities, and cooperative, positive participation. The Mogollon Monster Mudda may dismiss, without refund, anyone whose behavior endangers safety or negatively endangers safety or negatively affects a race, a person, a facility, or property of any type or kind. I also agree to indemnify Town of Payson, its affiliates and assigns, from any and all third party claims caused in whole or in part by my actions.

Waiver & Release of all claims & assumption of risk:

PARTICIPATION RELEASE: In consideration of being allowed to participate in any way in Payson Parks, Recreation and Tourism Mountain High Games, related events and activities, the undersigned acknowledges, appreciates and agrees that: the risk of injury from the activities involved in this program is significant, including the potential for permanent paralysis and death, and while particular rules, equipment, and personal discipline may reduce this risk, the risk of serious injury does exist; and, I knowingly and freely assume all such risks, both known and unknown, if arising from the negligence of the releasee or others, and assume full responsibility for my participation; and, I willingly agree to comply with the stated and customary terms and conditions for participation.

If, however, I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the nearest official immediately; and, I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, HEREBY RELEASE AND HOLD HARMLESS The Town of Payson, Payson Parks and Recreation, its officers, officials, agents and/or employees, and if applicable, owners and lessors of premises used to conduct the event (releasees), WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, or loss or damage to person or property, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, to the fullest extent permitted by law. I have read this release of liability and assumption of risk agreement, fully understand its terms, understand that I have given up substantial rights by signing it, and sign it freely and voluntarily without any inducement. Your signature is required otherwise your registration will not be processed.

Participants, who AGREE hereon, understand that this is a full contact physical activity and may be hazardous, & agree to accept full responsibility for their own personal safety and well being. Participants must carry their own medical/accident insurance, & agree to hold harmless, the Town of Payson & its contractors/subcontractors, its officers, all sponsors, contributors, land management agencies, guides, volunteers & any others who help organize, or carry out this event.

READ THE SECTION BELOW IF YOU ARE A PARENT OR GUARDIAN OF A PARTICIPANT UNDER THE AGE OF 18 but older than 12 years of age (you must be 12 years of age on the date of the race to compete - there will be no exceptions):
